Plant processes continue to perform well.

Miscellaneous

As the wet weather season approaches, citizens have expressed concern about our level of preparedness for wet weather events at the WWTP. Plant staff has adopted a policy of being prepared year 'round for rain events with a heightened focus during the winter months.

Below is a list of preventative measures that Plant Staff has undertaken, and continue to practice in order to be ready for storm and flooding events.

2012

- Installed shunt trip by-pass switch. In the event the shunt trip shorts out, we can use the bypass switch to continue operation.
- Raised the shunt trip to 4 feet above ground level.
- All 12 inch valves associated with the emergency diesel pump are chained open.
- Emergency pump left connected year 'round.
- Installed raised lid on electric vault near headworks.
- Developed new Standard Operating Procedures for Emergency Operating situations.

- Replaced wiring at influent pump station.
- Installed drainage ditch at generator building.
- Provide regular training for staff on emergency procedures.

2013 -14

- Replaced influent pumps # 3 and #4 with new 40 hp pumps (3500 gal/min capacity).
- Replaced FFR pump motors #1 and #2 with 60hp motors for more capacity.
- Installed # 3 pump at FFR.
- Plant staff attended the SLO County Arroyo Grande Creek Levee Failure Emergency Response Plan Training with SLO Co. Public Works Dept.
- Developed Plant-wide valve exercise program.

As a matter of standard practices we currently perform the following tasks as indicated:

- Run the emergency generator for 20 minutes every two weeks. We also run it under full load every six months.
- Run the diesel emergency bypass pump every two weeks. We fully operate the pump once every three months.
- The emergency generator and the 10 MGD emergency by-pass pump are serviced semi-annually by the dealer.
- 6 inch, 3 inch and 2 inch portable pumps are checked bi-weekly for proper operation.
- All storm water sump pumps are operated weekly to insure readiness.
- Sump pump replacements are kept in stock.
- Check the amp draw on the sump pumps twice a year. (Late summer and early spring).
- Clean underground electrical vaults on a regular basis.
- Clean plant storm drains on a regular basis.
- Exercise all plant water and sludge valves on a semi-annual basis.
- Participate in a multi-agency emergency preparedness agreement.
- Maintain a stockpile of sand for diversion of water in case of flood (Sand is eventually used for filtration in sludge beds).
- SLO County has installed level sensors at key waterways and will share rising water notifications with the District.

FY 2015 WaterSMART: Title XVI Water Reclamation and Reuse Projects

Agency: Bureau of Reclamation **Latest Solicitation:** 10/30/2014 – 12/15/2014

Award Range: Up to \$4,000,000

Total Funding: \$21,500,000

Match: 75%

Summary: The Bureau of Reclamation's Title XVI Water Reclamation and Reuse program is an important part of the Department of Interior's WaterSMART program. Under Title XVI of Public Law 102-575, the Bureau of Reclamation works to identify and investigate opportunities to reclaim and reuse wastewater and naturally impaired ground and surface water in the 17 Western States and Hawaii. Title XVI also provides authority for Reclamation to provide up to the 25 percent of the cost of planning, designing, and constructing congressionally authorized water recycling projects.

For purposes of the Title XVI Program, a water reuse project is a project that reclaims and reuses municipal, industrial, domestic, or agricultural wastewater and naturally impaired groundwater and/or surface waters. Reclaimed water can be used for a variety of purposes such as environmental restoration, fish and wildlife, groundwater recharge, municipal, domestic, industrial, agricultural, power generation, or recreation.

Title XVI projects develop and supplement urban and irrigation water supplies through water reuse, thereby improving efficiency, providing flexibility during water shortages, and diversifying the water supply. Title XVI projects provide growing communities with new sources of clean water while promoting water and energy efficiency and environmental stewardship. Through water reuse, Title XVI projects increase water management flexibility, making our water supply more resilient and thereby helping to prepare for the impacts of climate change.

Applicant Eligibility: Sponsors of water reclamation and reuse projects specifically authorized for funding under Title XVI of Public Law 102-575 are eligible to apply for funding through this program.

Funding Details: The President's FY 2015 budget request includes \$21.5 million for this Title XVI funding opportunity. The amount of funding available for awards is dependent on final FY 2015 appropriations.

Reclamation anticipates providing no more than \$4,000,000 per applicant. Reclamation may consider awards of more than \$4,000,000 per applicant if final program funding is sufficient.

Project awards will be made through grants or cooperative agreements as applicable to each project. If a cooperative agreement is awarded, the recipient should expect Reclamation to have substantial involvement in the project. Substantial involvement by Reclamation may include the following:

- Collaboration and participation with the recipient in the management of the project and close oversight of the recipient's activities to ensure that the program objectives are being achieved
- Oversight that may include review, input, and approval at key interim stages of the project

Match Requirements: The Federal share of an authorized Title XVI project (Reclamation's share plus any other sources of Federal funding), including any funding provided as a result of this funding opportunity, cannot exceed 25 percent of the total project cost. In-kind contributions, pre-award costs, and indirect costs may be included as part of the project's budget.

FY 2015 WaterSMART: Water and Energy Efficiency Grants

Agency: Bureau of Reclamation **Latest Solicitation**: 10/30/2014 – 1/14/2015

Award Range: Up to \$1,000,000

Total Funding: \$18,200,000

Match: 50%

Summary: Through the WaterSMART Grants Reclamation provides 50/50 cost share funding for projects that seek to conserve and use water more efficiently, increase the use of renewable energy and improve energy efficiency, benefit endangered and threatened species, facilitate water markets, or carry out other activities to address climate-related impacts on water or prevent any water-related crisis or conflict. Water conservation and efficiency are crucial to most western States' plans to ensure that water is available to meet demands into the future.

Reclamation is also making funding available for water management improvements that complement other ongoing efforts to address water supply sustainability. For example, through the WaterSMART Basin Study Program, Reclamation is working with State and local partners, as well as other stakeholders, to comprehensively evaluate the ability to meet future water demands within a river basin. The Basin Studies allow Reclamation and its partners to evaluate potential impacts of climate change to water resources within a particular river basin, and to identify adaptation strategies to address those impacts. Partners who have completed a Basin Study may apply for cost-shared funding to implement Basin Study adaptation strategies that meet the eligibility and requirements of this solicitation.

In addition, funding is available for water delivery system improvements that will enable farmers to make additional on-farm improvements in the future, including improvements that may be eligible for Natural Resources Conservation Service (NRCS) funding.

Applicant Eligibility: Eligible applicants are states, tribal entities, irrigation districts, water districts, or other organizations with water or power delivery authority located in the western United States or United States Territories.

Funding Details: The President's FY 2015 budget request includes \$19 million for WaterSMART grants. The amount of actual funding available for awards is dependent on final FY 2015 appropriations. Approximately \$800,000 of FY 2015 WaterSMART grant funding, if available, will be allocated to additional phases of projects selected through previous years' solicitations. Reclamation will allocate funding to projects in two groups:

- Projects in Funding Group I may receive up to \$300,000 for a project with a performance period of up to two years.
- Projects in Funding Group II may receive up to \$1,000,000 for a larger, phased project that can be completed within three years. Each phase of projects in this group will be funded on an annual basis, and can receive no more than \$500,000 in a given year. Each phase of the project is expected to be completed within one year of the award.

Reclamation expects that the majority of awards will be made for projects in Funding Group I.

Match Requirements: The Federal share of a proposed project (Reclamation's share plus any other sources of Federal funding) cannot exceed 50 percent of the total project cost. In-kind contributions, pre-award costs, and indirect costs may be included as part of the project's budget.
