6A. RECOMMENDATION OF AWARD FOR WWTP REDUNDANCY PROJECT STARTUP AND OPERATIONS CONSULTING SERVICES CONTRACT WITH PERC WATER CORPORATION

District Administrator Ghent presented this item.

District Administrator to execute a contract for Startup and Operations Consulting Services for the Wastewater Treatment Plant with Perc Water Corporation in the amount of \$299,672 and authorize the District Administrator to review and approve changes to the contract for up to 10% of the initial amount, or \$29,967, for a

total potential amount of \$329,639.

6B. 2022/23 FISCAL YEAR BUDGET; SET PUBLIC HEARING FOR JUNE 1, 2022

Bookkeeper Simpson presented this item in PowerPoint. The FY 2022/23 Budget anticipates a balanced budget of \$21,545,700 in both Revenues and Expenses. A large portion of the proposed budget is the Redundancy Project.
